FAMILY SHELTER PROVIDES FOR THE IMMEDIATE NEEDS OF FAMILIES AND OFFERS A WIDE RANGE OF SUPPORTIVE SERVICES ALONGSIDE OF THE SHELTER.

THE ORGANIZATION IS A MEMBER OF THE HOMELESS SERVICES COALITION OF GREATER KANSAS CITY AND THE KANSAS CITY CONTINUUM OF CARE. RESTART ALSO WORKS WITH PRIVATE AND GOVERNMENT ORGANIZATIONS TO ENSURE THAT HOMELESS INDIVIDUALS AND FAMILIES HAVE ACCESS TO THE SERVICES THEY NEED AND ARE ELIGIBLE FOR, AS WELL AS TO AVOID UNNECESSARY DUPLICATION OF SERVICES.
